Adult Waiver & Release (18+)

READ CAREFULLY – LEGAL RELEASE OF LIABILITY

In consideration of entry into Mad Jack's Haunted House Full Contact Experience, I, the undersigned, agree as follows:

Release of Liability & Assumption of Risk. I release, waive, and discharge Mad Jack's Haunted House, its owners, staff, contractors, actors, affiliates, and all other Releasees from any liability for injury, death, property damage, or loss, including those arising from negligence. I understand participation involves serious inherent risks, including but not limited to extreme darkness, confined spaces, strobe lights, fog, loud noises, disturbing imagery, simulated suffocation or confinement, restraint, sensory deprivation or overload, proximity to actors and props, intentional physical contact, strong scents, vibrations, and other effects designed to create fear and discomfort. I expressly assume all such risks, known or unknown, and accept that safety cannot be guaranteed.

Medical & Emergency Care. I certify that I am physically able to participate and will disclose any medical conditions, including allergies to latex or other allergens. I understand that participation is not recommended for pregnant individuals, and I have been advised to consult with a physician if I am pregnant or have any health concerns. I authorize emergency medical care if necessary, release the Releasees from liability for such care, and accept full financial responsibility for any related expenses.

Express Assumption of Risk. By signing this waiver, I expressly and voluntarily assume all risks described above, including potential physical, emotional, or psychological injury, and accept full personal responsibility for my participation.

Communicable Diseases. I acknowledge the risk of exposure to COVID-19 and other communicable illnesses during participation and accept full responsibility for such risks.

Conduct & Rules. I will not touch or act aggressively toward actors, staff, props, or other guests. I must wear closed-toe shoes and appropriate clothing. Use of the safe word "APPLES" or removing the red pendant ends Full Contact participation.

Age & Identification. I am 18+ with a valid government-issued ID. I understand fingerprinting and ID verification are required.

Media Release. I grant Mad Jack's Haunted House the right to use my image, voice, and likeness in all media without compensation.

Confidentiality. I agree not to disclose or share proprietary or confidential information regarding the Full Contact Experience.

Indemnity. I agree to indemnify and hold harmless the Releasees from any claims arising from my participation. All fees are non-refundable.

Governing Law. This Agreement is binding under Oklahoma law and enforceable to the fullest extent permitted by law.

Assumption of Personal Responsibility. I accept full responsibility for my actions during the Full Contact Experience. I will follow all rules, instructions, and safety guidelines provided by Mad Jack's Haunted House, LLC, and acknowledge that failure to do so may increase risks.

No Guarantee of Safety. I understand and acknowledge that, despite precautions taken by the Releasees, safety cannot be guaranteed. Participation in the Full Contact Experience is at my own risk, and the Releasees make no promises or warranties regarding the prevention of injury, harm, or damage.
